Freedom Motors Inc (“Savaria”) Limited Warranty for Rear Entry Van Conversions

Freedom Motors Inc, “Savaria”, warrants to the original purchaser of this product that the company will repair or replace at its option, parts that fail by reason of defective material or workmanship as follows:

- Repair for a period of 3 years or 60,000 km (37,250 miles), whichever occurs first, the structural metal components of the installed lowered floor and ramp. These components are warranted for “rust through” damage. Surface rust is not covered.
- The cost of the Savaria conversion component parts or some OEM parts modified by Savaria will be covered for a period of 3 years or 60,000 km (37,250 miles), whichever occurs first.
- Labour cost for the above mentioned parts for 3 years or 60,000 km (37,250 miles), whichever occurs first.
- Parts and labour costs for conversion (non OEM) exhaust system for a period of 12 months or 20,000 km whichever occurs first.
- All repairs (rework) are warranted for a period of 3 months or 5,000 km (3,100 miles), whichever occurs first.

For all other components made by other manufacturers, the warranty of these manufacturers’s shall apply.

Diagnostic work or troubleshooting is not covered by this warranty.

IMPORTANT: The warranty registration card must be COMPLETED AND RETURNED to Savaria within 30 days, after receiving this Savaria product, for the warranty to be valid

Savaria reserves the right to discontinue models or options, change specifications, materials, equipment or design at any time without notice and without incurring obligations.

This warranty is in lieu of any other warranty expressed or implied. This warranty covers only those parts installed by Savaria and is intended to supplement vehicle manufacturer’s warranty. Refer to vehicle manufacturer’s warranty for coverage on original vehicle equipment.

Original Equipment Manufacturer Warranty: The terms of the general warranty policy provided on your vehicle by the Original Equipment Manufacturer and/or Distributor is applicable. Warranty coverage pertaining to general factory or bumper-to-bumper coverage, powertrain warranty, corrosion warranty, safety restraint system warranty and emissions control warranty are provided exclusively on this vehicle by the Original Equipment Manufacturer and/or Distributor. For specific policy information, terms, conditions and exclusions, please contact the Original Equipment Manufacturer and/or Distributor.

Savaria Limited Warranty: Savaria provides a warranty on its conversion for wheelchair accessibility, hereinafter referred to as “The Savaria Limited Warranty”. Savaria warrants that its conversion is free from defects in material or workmanship according to the terms herein. The Savaria Limited Warranty is independent of the warranty offered on your vehicle by the Original Equipment Manufacturer and/or Distributor and is an additional warranty provided by Savaria.

The Savaria Limited Warranty commences on the day the vehicle is delivered to the original owner of the conversion from Savaria. Savaria warrants that it will repair or replace, free of charge, any aspect of its conversion which, under normal conditions of use and service, proves to be defective in material or workmanship, on the condition that such defect shall become apparent while the original owner of the conversion from Savaria remains the owner of the vehicle and that such defects impair the functionality of the conversion.

Limitations and Exclusions

The Savaria Limited Warranty covers all material and labor costs preauthorized by Savaria. Savaria reserves the right to determine where repair work is to be performed.

- The Savaria Limited Warranty applies to the original owner of the conversion and is not transferable to subsequent owners.
- The Savaria Limited Warranty does not cover any defects or failures caused by acts of nature, misuse, negligence, improper or lack of maintenance, road hazards, modification, failure to use appropriate towing or hoisting instructions, abuse, accident, unauthorized repair work or normal wear and tear.
- The Savaria Limited Warranty does not cover towing charges or incidental or consequential damages such as loss of use of vehicle, loss of time, loss of income, inconvenience or travel, food and accommodation expenses.
- The Savaria Warranty does not cover repairs and replacements to tie-down straps (retractors), shock absorbers or parts designed and manufactured by parties other than Savaria. However, the producers of these parts may provide a warranty on the parts independent of the Savaria Warranty. If you are interested in obtaining the applicable warranty policies provided by the producers of these parts, please contact Savaria. For warranty claims regarding Q'Straint retractors, Savaria may refer you to Q'Straint directly.
- The Savaria Warranty does not cover repairs and replacement to the exhaust and emissions control system, except as required by law.
- The Savaria Limited Warranty does not cover repairs to vehicles that are registered or operated in countries other than the United States, territories of the United States and Canada.
- Purchase price for product must have been paid in full to Savaria for the warranty to be considered valid.
- To the extent permitted by law, the Savaria Limited Warranty is provided in lieu of all other express and implied warranties, including the implied warranties of merchantability and fitness for a particular purpose.

To make a claim for warranty coverage under the Savaria Limited Warranty, the owner of the conversion must contact Savaria to request coverage prior to any work performed to repair the conversion. Unauthorized repairs or parts replacement by someone other than an authorized Savaria vehicle dealer is not covered by this warranty.
